The Project

A well-reputed Cambridge-based bank decided to tighten the protection against fraud in its payments services by incorporating security tokens. Doing so required revision of payments agreement and signature pages for the various payment methods and platforms.

Payments from the bank's online platform include wires and ACH origination. Customers can also make wire transfers by phone, fax, and in person. The bank also wanted to make the entire process as easy and convenient as possible for customers and bank staff, and to comply with all government rules and regulations. The Result

Graber Associates recommended that the bank create three (3) payment agreements, with a single signature page per agreement. The agreements cover any and all combinations of online/offline payment instruction origination as well as wire and ACH payment options. The bank will use whichever agreement fits the customer's situation.

The customer will have specific instructions for payments requirements and just one place to sign. Customers also can move from agreement to agreement as their requirements for payment methods change.

The bank's operations staff, product managers, senior management, security team, and legal department signed off on all three agreements. The bank put the agreements into use immediately and distributed the security tokens to its customers.
